

**ORDINANCE NO. 3921-11**

**AN ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF FRANKLIN, SOMERSET COUNTY, NEW JERSEY, CHAPTER 166, DRUG-FREE ZONES, ARTICLE II, PUBLIC HOUSING, PUBLIC PARKS AND PUBLIC BUILDING ZONES, SECTION 166-6, MAPS ADOPTED AND SECTION 166-8, NOTIFICATION OF CHANGE OF PUBLIC HOUSING, PUBLIC PARKS AND PUBLIC BUILDING PROPERTIES.**

**SUMMARY**

An ordinance amending the Code Chapter 166, Drug-Free Zones, Public Housing, Public Parks and Public Building Zone Maps as per Section 166-6 and the Notification of Change of Public Housing, Public Parks and Public Building Properties as per Section 166-8.

**BE IT ORDAINED** by the Township Council of the Township of Franklin, County of Somerset and State of New Jersey, Franklin Township Code Chapter 166, Drug-Free Zones, Article II, Public Housing, Public Parks and Public Building Zones is hereby amended as follows:

**SECTION I**

**ARTICLE II, Public Housing, Public Parks and Public Building Zones [Adopted 10-12-1999 by Ord. No. 3077 (Ch. 119 of the 1990 Code)]**

**§ 166-6. Maps adopted. [Amended 10-8-2002 by Ord. No. 3322]**

In accordance with and pursuant to the authority of P.L. 1997 c. 327(1) [N.J.S.A. 2C:35-7.1], the Drug-Free Public Housing, Public Parks and Public Building Zones Maps produced as set forth below are hereby approved and adopted as official findings and records of the locations and areas within the municipality of property which are used for public housing, public parks and public building zones, and of the areas in or within 500 feet of such public housing, public parks and public building zones. A copy of said maps are on file in the Township of Franklin Municipal Clerk's office.

**§ 166-7. Maps to constitute official finding and record.**

The Drug-Free Public Housing, Public Parks and Public Building Zones Maps approved and adopted pursuant to § 166-6 of this article shall continue to constitute an official finding and record as to the location and boundaries of 500 feet of property which is used for Drug-Free Public Housing, Public Parks and Public Building Zones purposes until such time, if any, that this article shall be amended to reflect any additions or deletions with respect to the location and boundaries of properties and Drug-Free Public Housing, Public Parks and Public Building Zones.

**§ 166-8. Notification of change of public housing, public parks, and public building properties. [Amended 10-8-2002 by Ord. No. 3322]**

As noted below the following agencies are hereby directed and shall have the continuing obligation to promptly notify the Municipal Engineer and the Municipal Attorney of any changes or contemplated changes in the location and boundaries of any property which is used for Drug-Free Public Housing, Public Parks and Public Building Zones purposes:

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

**SECTION IV**

This ordinance shall take effect immediately upon adoption and publication according to law.
