

ORDINANCE NO. 3936-11

AN ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET, STATE OF NEW JERSEY, MORE PARTICULARLY CHAPTER 5, ADMINISTRATION OF GOVERNMENT, ARTICLE II EXECUTIVE AND LEGISLATIVE, SECTION 5-4, MEETINGS OF TOWNSHIP COUNCIL, SUBSECTION F - STANDING COMMITTEES.

SUMMARY

An Ordinance amending the Standing Committees by separating the Administration and Financial Oversight Standing Committee into two (2) separate standing committees.

BE IT ORDAINED by the Township Council of the Township of Franklin, County of Somerset, State of New Jersey that the Code of the Township of Franklin be and it is hereby amended as follows:

SECTION I

Chapter 5, Administration of Government, Article II, Section 5-4 - Meetings of Township Council, Subsection F - Standing Committees are hereby amended as follows:

§ 5-4. Meetings of Township Council. [Amended 3-14-2000 by Ord. No. 3115; Amended 11-12-2002 by Ord. No. 3333]

- F. Standing committees. [Added 2-8-2005 by Ord. No. 3525; Amended 6-14-2005 by Ord. No. 3549; Amended 9-8-2009 by Ord. No. 3839]
- (1) There shall be ~~four~~ **five** standing committees of the Township Council as follows:
 - (a) Administration and Financial Oversight.
 - (b) Financial Oversight.**
 - ~~(c)~~ Public Safety.
 - ~~(d)~~ Land Use, Open Space, Parks and Recreation .
 - ~~(e)~~ Public Works.
 - (2) The standing committees shall consist of four members of the Township Council appointed by the Township Council in January of each year.

SECTION II

Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the ordinance shall not be affected.

SECTION III

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

SECTION IV

This ordinance shall take effect immediately upon adoption and publication according to law.
