

ORDINANCE NO. 3592

ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET AND STATE OF NEW JERSEY, MORE PARTICULARLY CHAPTER 180, FEES, ARTICLE I, PUBLIC RECORDS, SECTION 180-1 AVAILABLE FROM TOWNSHIP CLERK (ADDING FEES FOR THE SALE OF THE MUNICIPAL CODE BOOK AND ANNUAL SUBSCRIPTION OF THE MUNICIPAL CODE).

SUMMARY

An ordinance amending chapter 180, Fees, by adding fees for the Sale of the Municipal Code Book (\$100) and Annual Subscription of the Municipal Code (\$25 per year).

BE IT ORDAINED by the Township Council of the Township of Franklin, County of Somerset and State of New Jersey that the Code of the Township of Franklin be and it is hereby amended as follows:

SECTION I

Chapter 180, Fees, Article I, Public Records is hereby amended in its entirety as follows:

**ARTICLE I
Public Records**

180-1. Available from Township Clerk

A. The Township Clerk of the Township of Franklin shall be authorized to charge for making available to the public the following documents:

- (1) Franklin Township Master Plan: Seventy-five dollars (\$75.).
- (2) Zoning and Subdivision Ordinances: Thirty dollars (\$30).
- (3) Ward Map: Three dollars (\$3.).
- (4) Street Map: Three dollars (\$3.).
- (5) Off-Site Condition Disclosure Act Maps and Reports: Ten dollars (\$10.00).
- (6) Retrieval of records stored off site:
 - (a) Retrieval and delivery charge: Thirty dollars (\$30.)
 - (b) Per box charge: Ten dollars (\$10.)
- (7) *Franklin Township Municipal Code Book: One Hundred dollars (\$100).*
- (8) *Annual Subscription of Municipal Code: Twenty-five dollars (\$25) per year.*

SECTION II

Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the Ordinance shall not be affected.

SECTION III

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

SECTION VI

This ordinance shall take effect immediately upon adoption and publication according to law.
