

**ORDINANCE NO. 3620**

**AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET AND STATE OF NEW JERSEY, MORE PARTICULARLY CHAPTER 226 - VEHICLES AND TRAFFIC, SECTION 226-20 – STOP INTERSECTION (LEUPP LANE; SECTION 226-28 – SPEED LIMITS (SCHOOLHOUSE ROAD BETWEEN RANDOLPH ROAD AND WESTON CANAL ROAD – 40 MPH) AND SECTION 226-30 – ON-STREET HANDICAPPED PARKING (166/168 JOHN F. KENNEDY BLVD.)**

**SUMMARY**

An ordinance amending the Vehicles & Traffic Ordinance as follows: Amend Section 226-20 – Stop Intersections (Add Leupp Lane); Section 226-28 – Speed Limits (Increase speed limit of Schoolhouse Road between Randolph Road and Weston Canal Road to 40 mph.) and Section 226-30 – On-Street Handicapped Parking (Add 166/168 John F. Kennedy Blvd.)

**BE IT ORDAINED** by the Township Council of the Township of Franklin, County of Somerset and State of New Jersey as follows:

**SECTION I**

**Section 226-20, Stop Intersections**, is amended to **add** therefrom the following:

**§ 226-20. Stop Intersections.**

Pursuant to the provisions of N.J.S.A. 39:4-140, the intersections described are hereby designated as stop intersections. Stop signs shall be installed as provided therein.

<b><u>Intersection</u></b>	<b><u>Stop Signs On:</u></b>
Leupp Lane and Tamarack Road	Tamarack Road
Leupp Lane and Tamarack Road	Tamarack Road
Leupp Lane and Layne Road	Layne Road
Layne Road and Kyle Road	Kyle Road

**SECTION II**

**Section 226-28, Speed Limits**, is amended to **add** therefrom the following:

**§ 226-28. Speed limits.**

The speed limits for both directions of traffic along the following streets are established as follows:

<b><u>Street</u></b>	<b><u>Speed Limit (mph) and Location</u></b>
Schoolhouse Road	40 mph (Between Randolph Rd. & Weston Canal Rd.)

**SECTION III**

**Section 226-30, Handicapped Parking Spaces on Street**, is amended to **add** therefrom the following:

**166/168 John F. Kennedy Blvd.**

Actual location is on a “frontage road” off of John F. Kennedy Blvd. Beginning at a point 163 feet north of the southerly lot limit of Block 403, Lot 9 and continuing 25 feet therefrom.

**SECTION IV**

Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the Ordinance shall not be affected.

**SECTION V**

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

**SECTION VI**

This ordinance shall take effect immediately upon adoption and publication according to law.
