

**ORDINANCE NO. 3642**

**AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET AND STATE OF NEW JERSEY, MORE PARTICULARLY CHAPTER 226 - VEHICLES AND TRAFFIC, SECTION 226-20 – STOP INTERSECTIONS (KUHN STREET AND HADLER DRIVE AREA)**

**SUMMARY**

An ordinance amending the Traffic Ordinance to add the following stop intersections in the Kuhn Street and Hadler Drive Area: Flower Road and Sebring Road with stop on Flower Road; Sebring Road and Hadler Drive with stop on Sebring Road; Bartle Road and Hadler Drive with stop on Bartle Road; Bartle Road and Kuhn Street with stop on Bartle Road; Kuhn Street and Hadler Drive with stop on Kuhn Street; Hill Avenue and Lake Avenue with stop on Hill Avenue; Hill Avenue and Kuhn Street with stop on Hill Avenue; Lake Avenue and Kuhn Street with stop on Lake Avenue; Spring Street and Kuhn Street with stop on Kuhn Street; Dennett Road and Flower Road with stop on Dennett Road; Dennett Road and Hadler Drive with stop on Dennett Road.

**BE IT ORDAINED** by the Township Council of the Township of Franklin, County of Somerset and State of New Jersey, Franklin Township Code Chapter 226, Traffic and Vehicles is hereby amended with the addition of the following:

**SECTION I**

**Section 226-20. STOP INTERSECTIONS.**

Pursuant to the provisions of N.J.S.A. 39:4-140, the intersections described are hereby designated as Stop Intersections. STOP signs shall be installed as provided therein.

Dennett Road and Flower Road	Dennett Road
Dennett Road and Hadler Drive	Dennett Road

**SECTION II**

Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the Ordinance shall not be affected.

**SECTION III**

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

**SECTION IV**

This ordinance shall take effect immediately upon adoption and publication according to law.
