

ORDINANCE NO. 3650

AN ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET, STATE OF NEW JERSEY MORE PARTICULARLY CHAPTER 62 - SALARIES & COMPENSATION – SECTION 62-3 ANNUAL BASE COMPENSATIONS FOR ELECTED AND APPOINTED EMPLOYEES/OFFICIALS AND SECTION 62-4 ANNUAL COMPENSATION AND LONGEVITY FOR MANAGERIAL AND EXEMPT EMPLOYEES

SUMMARY

An Ordinance Amending the Salary Ordinance by establishing the following salary ranges: Township Prosecutor: \$20,000 to \$35,000; Associated Prosecutor: \$10,000 to \$20,000 and Township Public Defender: \$10,000 to \$20,000; Increasing Range \$37,000 to \$70,800 under the Managerial and Exempt Employees to Range \$37,000 to \$77,000; and deleting the following salary titles: Purchasing Agent and Administrative Aide to the Township Manager.

BE IT ORDAINED by the Township Council of the Township of Franklin, County of Somerset, State of New Jersey that the Code of the Township of Franklin be and it is hereby amended as follows:

SECTION I

Chapter 62, Salaries and Compensation, Section 62-3, Annual Base Compensations for Elected and Appointed Employees/Officials is hereby amended as follows:

62-3. Annual Base Compensations for Elected and Appointed Employees/Officials.

SECTION II

Chapter 62, Salaries and Compensation, Section 62-34, Annual Compensation and Longevity for Managerial and Exempt employees is hereby amended as follows:
