

ORDINANCE NO. 3732

AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET AND STATE OF NEW JERSEY, MORE PARTICULARLY CHAPTER 226 - VEHICLES AND TRAFFIC, SECTION 226-22, TURN PROHIBITIONS AND SECTION 226-30, HANDICAPPED PARKING.

SUMMARY

An ordinance amending the Traffic Ordinance to add the following Turn Prohibitions: Route 27 and Holland Drive; Easton Avenue and Frontage Road (Curb opening on western curb-line 380' south of the south curb-line of Foxwood); Cedar Grove Lane (Driveway of #152); Easton Avenue (Exit of Driveway #1714) and Elizabeth Avenue (Exit Driveway from Shop Rite located 150 feet south of Happer Street) and to add 283 Park Street as an on-street handicapped parking space.

BE IT ORDAINED by the Township Council of the Township of Franklin, County of Somerset and State of New Jersey, Franklin Township Code Chapter 226, Traffic and Vehicles is hereby amended with the addition of the following:

SECTION I

Section 226-22. TURN PROHIBITIONS.

No person shall make a turn at any locations listed and only in the manner described.

<u>Intersection</u>	<u>Turn Prohibited</u>	<u>Movement Prohibited</u>
Route 27 and Holland Drive	Left	From Holland Drive eastbound to Route 27 northbound
Easton Avenue and Frontage Avenue <i>*Curb opening on western curb-line 380' south of the south curb-line of Foxwood</i>	Left/Right	From Frontage Road north and south bound to Easton Avenue north and south bound
Cedar Grove Lane <i>*Driveway of #152</i>	Left	From driveway to Cedar Grove Lane southbound between the hours of 7am to 9am and 4pm to 6pm.
Easton Avenue <i>*Exit Driveway #1714</i>	Left	From exit driveway to Easton Avenue northbound
Elizabeth Avenue <i>*Exit Driveway from Shop Rite located 150 feet south of Happer Street</i>	Left	From exit driveway to Elizabeth Avenue southbound

SECTION II

Section 226-30. HANDICAPPED PARKING.

A. Handicapped Parking on Street.

- (1) Pursuant to the authority granted to this municipality by N.J.S.A. 39:4-197, the following locations are hereby designated as restricted parking spaces for use by persons who have been issued special vehicle identification cards by the Division of Motor Vehicles. No other person shall be permitted to park in these spaces.

<u>Street</u>	<u>Number of Spaces</u>	<u>Location</u>
283 Park Street	1	Along the northern road edge beginning at a point 125 feet east of Baier Avenue and ending at point 150 feet east of Baier Avenue

SECTION III

Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the Ordinance shall not be affected.

SECTION IV

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

SECTION V

This ordinance shall take effect immediately upon adoption and publication according to law.
