

ORDINANCE NO. 3734

AN ORDINANCE AMENDING THE MUNICIPAL CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET, STATE OF NEW JERSEY, CHAPTER 236, MUNICIPAL SERVICES, SECTION 236-4, SCHEDULE A – STREET LIGHTING – SOMERSET RUN CONDOMINIUM ASSOCIATION INC.

An ordinance amending Chapter 236, Municipal Services, Section 236-4, Schedule A by adding qualified streets, qualified street lighting poles and conditionally qualified street lighting poles for Somerset Run Condominium Association Inc.

BE IT ORDAINED by the Township Council of the Township of Franklin, County of Somerset and State of New Jersey, Franklin Township Code Chapter 236, Municipal Services is hereby amended with the addition of the following:

SECTION I

Chapter 236, Municipal Services, Schedule A is amended by adding thereto the following:
