

ORDINANCE NO. 3745

AN ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF FRANKLIN, SOMERSET COUNTY, NEW JERSEY, CHAPTER 166, DRUG-FREE ZONES, ARTICLE I, SCHOOL ZONES, SECTION 166-1, MAPS ADOPTED WITH THE ADDITION OF THE ETERNAL LIFE CHRISTIAN CENTER.

SUMMARY

An ordinance amending the Code Chapter 166, Drug-Free Zones, Article I, School Zones, Section 166-1, Maps Adopted with the addition of Eternal Life Christian Center.

BE IT ORDAINED by the Township Council of the Township of Franklin, County of Somerset and State of New Jersey, Franklin Township Code Chapter 166, Drug-Free Zones, Article I, School Zones, Section 166-1, Maps Adopted is hereby amended with the addition of the following:

SECTION I

ARTICLE I, School Zones [Adopted 4-26-1994 by Ord. No. 1831 (Ch. 120 of the 1990 Code)]

§ 166-1. Maps adopted.

In accordance with and pursuant to the authority of L. 1988 c. 44 (N.J.S.A. 2C:35-7), the Drug-Free School Zone Maps produced as set forth below are hereby approved and adopted as official findings and records of the locations and areas within the municipality of property which is used for school purposes and which is owned by or leased to any elementary or secondary school or school board, and of the areas on or within 1,000 feet of such school property. A copy of said maps are on file in the Township of Franklin Municipal Clerk's Office.
