

**ORDINANCE NO. 3775**

**AN ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET, STATE OF NEW JERSEY MORE PARTICULARLY CHAPTER 62 - SALARIES & COMPENSATION – SECTION 62-3 ANNUAL BASE COMPENSATIONS FOR ELECTED AND APPOINTED EMPLOYEES/OFFICIALS.**

**SUMMARY**

An Ordinance Amending the Salary Ordinance by removing Township Attorney; Planning Board Attorney; Board of Adjustment Attorney; Rent Leveling Attorney; Township Prosecutor; Associate Prosecutor and Township Public Defender from Section 62-3, Annual Base Compensations for Elected and Appointed Employees/Officials.

**BE IT ORDAINED** by the Township Council of the Township of Franklin, County of Somerset, State of New Jersey that the Code of the Township of Franklin be and it is hereby amended as follows:

**SECTION I**

**Chapter 62, Salaries and Compensation, Section 62-3, Annual Base Compensations for Elected and Appointed Employees/Officials** is hereby amended as follows:

**62-3. Annual Base Compensations for Elected and Appointed Employees/Officials.**

The following Annual Base Compensations for elected and appointed employees/officials are herein established effective ~~July 1, 2005~~ **January 1, 2009 unless otherwise stated: [Amended 4/8/98 by Ords. #2064, 2072, 3577]**

**SECTION II**

Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the ordinance shall not be affected.

**SECTION III**

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

**SECTION IV**

This ordinance shall take effect immediately upon adoption and publication according to law.
