

ORDINANCE NO. 3809

AN ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET, STATE OF NEW JERSEY, MORE PARTICULARLY CHAPTER 226, TRAFFIC AND VEHICLES, SECTION 226-10 – STOPPING OR STANDING PROHIBITED DURING CERTAIN HOURS AND SECTION 226-33 – RESIDENT PERMIT PARKING PROGRAM.

SUMMARY

This ordinance amends Code Chapter 226, Traffic and Vehicles, Section 226-10, Stopping or Standing Prohibited During Certain Hours by adds Dekalb Street, East Side, 24 hours from Franklin Blvd. to end and changes Section 226-33 – Resident Permit Parking Program Carmen Street from the west side to the east side from 8 pm to 8am, everyday, from Franklin Blvd. to Irvington Avenue.

BE IT ORDAINED by the Township Council of the Township of Franklin, County of Somerset, State of New Jersey that the Code of the Township of Franklin is hereby amended as follows:

SECTION I

Section 226-10, No Stopping or standing prohibited during certain hours on certain streets, is amended to add the following:

§ 226-10. Stopping or standing prohibited during certain hours on certain streets.

- A. No person shall stop or stand a vehicle between the hours specified upon any of the streets or parts of streets described.

SECTION II

Chapter 226, Vehicles and Traffic, Section 226-33, Resident Permit Parking Program, is amended by as follows:

§ 226-33. Resident Permit Parking Program

SECTION III

Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the ordinance shall not be affected.

SECTION IV

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as the extent of such inconsistency.

**SECTION VI**

This ordinance shall take effect immediately upon adoption and publication according to law.
