

ORDINANCE NO. 3818

AN ORDINANCE AMEND THE CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET, STATE OF NEW JERSEY, MORE PARTICULARLY CHAPTER 13, BOARDS, COMMISSIONS AND COMMITTEES, ARTICLE V, BUSINESS AND INDUSTRY ADVISORY BOARD, SECTION 13-11, MEMBERSHIP

SUMMARY

An Ordinance amending Chapter 13, Boards, Commissions and Committee to change the membership of the Business and Industry Advisory Board by changing “Economic Development Director” to “Economic Development Representative”; change “President of the Franklin Township Chamber of Commerce” to “Franklin Township Chamber of Commerce President or Designee”; and remove the restriction of “not affiliated with Chamber” from the following members: One business over 50 employees; One owner of retail center over 25,000 square feet; and One small business owner. 10 employees or fewer.

**BE IT ORDAINED** by the Township Council of the Township of Franklin in the County of Somerset and State of New Jersey as follows:

SECTION I.

The Municipal Code of the Township of Franklin, County of Somerset, New Jersey is hereby amended as follows:

**ARTICLE V, Business and Industry Advisory Board**

**§ 13-11 Membership**

The Board created shall consist of 18 members and shall have the powers hereinafter enumerated. The composition of the Board shall be as follows:

- A. Township Manager.
- B. Economic Development ~~Director~~ **Representative**.
- C. Township Director of Planning.
- D. Three members of the Township Council.
- E. One member of the Planning Board.
- F. One member of Board of Adjustment.
- G. ~~President of the Franklin Township Chamber of Commerce~~ **President or Designee**.
- H. Two members of the Franklin Township Chamber of Commerce.
- I. One business over 50 employees (~~not affiliated with Chamber~~).
- J. One owner of retail center over 25,000 square feet (~~not affiliated with Chamber~~).
- K. One small business owner, 10 employees or fewer (~~not affiliated with Chamber~~).
- L. One member of hotel industry.
- M. One commercial developer.
- N. School Superintendent or Designee
- O. Resident At-Large

**SECTION II.**

**Severability.**

If any section, subsection, paragraph, sentence or other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect or invalidate the remainder of this Ordinance, but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Ordinance directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Ordinance shall remain in full force and effect.

**SECTION III.**  
**Inconsistent Ordinances Repealed.**

All ordinances or parts of ordinances which are inconsistent with the provisions of this ordinance are hereby repealed, but only to the extent of such inconsistencies.

**SECTION IV.**  
**Effective Date.**

This Ordinance shall take effect immediately upon final adoption and publication in the manner prescribed by law.
