

ORDINANCE #3829, As Amended

AN ORDINANCE AMENDING CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET, NEW JERSEY CHAPTER 226, VEHICLES AND TRAFFIC, SECTION 226-31C - REGULATIONS FOR THE MOVEMENT AND THE PARKING OF TRAFFIC ON ALL OTHER PRIVATE PROPERTY - ADDING SOMERSET RUN.

SUMMARY

An ordinance amending Ordinance No. 3786 that provides for the regulations for the movement and the parking of traffic in Somerset Run including regulations for parking; stopping/standing prohibited; stop intersections; tow away and no passing zones.

BE IT ORDAINED by the Township Council of the Township of Franklin, County of Somerset and State of New Jersey as follows:

SECTION I

The Code of the Township of Franklin, Chapter 226, Vehicles and Traffic, Section 226-31C - Regulations for the Movement and Parking of Traffic on All Other Private Property is amended by including the following addition:

C. Regulations for the Movement and the Parking of Traffic on All Other Private Property

In accordance with the provisions of NJSA 39:5A-1, the regulations of Subtitle 1 of Title 39 are hereby made applicable to the properties listed.

Somerset Run State Statutory No Parking	No person shall park a vehicle upon any street in the complex in violation of any of the regulations described below: <ol style="list-style-type: none">1. All vehicles where permitted shall parked parallel to the curb-line facing in the direction of traffic, and within 6 inches of the road edge or curb-line.2. No vehicles shall be parked within an intersection.3. No vehicles shall be parked on a crosswalk.4. No vehicles shall be parked in front of a driveway.5. No vehicles shall be parked within 25 feet of a crosswalk or side-line of an intersecting street.6. No vehicles shall be parked on a sidewalk.7. No vehicles shall be parked within 50 feet of a stop sign.8. No vehicles shall be parked within 10 feet of a fire hydrant.9. No vehicles shall be parked in any appropriately marked space for the physically handicapped unless the vehicle is properly marked with an official permit.

Regulatory and Warning signs shall be erected and maintained to effect the above designated speed limits authorized by the Department of Transportation.

Somerset Run
Tow Away Zones

Any vehicle parked or standing as to obstruct or impede a normal flow of traffic, block entrances or exit ways, loading zones, oil fills, any grass area, pedestrian walkway, refuse containers or present in any way a safety or traffic hazard may be removed by towing the vehicle at the owner's or operator's expense.

Signs, pavement markings, installation and maintenance. All signs, posts, bolts or other necessary materials shall be installed and paid for by the applicant. Work shall be checked by the Police Department to insure installations meet state and federal specifications, and all signing shall conform to the current Manual on Uniform Traffic Control Devices.

Violations and penalties. Unless penalty is expressly provided by New Jersey statute, every person convicted of a violation of this section or any supplement thereto shall be liable to a penalty of not more than \$50 or imprisonment for a term not exceeding 15 days or both.

SECTION II

If any part of this regulation is for any reason held to be invalid, such decision shall not affect the validity of the remaining portion of the regulation.

SECTION III

This Ordinance shall take effect immediately upon adoption, publication and approval of the final site inspection according to law.
