

ORDINANCE NO. 3866-10

AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET AND STATE OF NEW JERSEY, MORE PARTICULARLY CHAPTER 226 - VEHICLES AND TRAFFIC, SECTION 226-20 – STOP INTERSECTIONS AND SECTION 226-31 (C) – REGULATIONS FOR THE MOVEMENT AND THE PARKING OF TRAFFIC ON ALL OTHER PRIVATE PROPERTY.

SUMMARY

An ordinance amending the Traffic Ordinance to add the following stop intersections for streets in the Battle Place/Davis Avenue area and Stop Intersections in Somerset Run.

BE IT ORDAINED by the Township Council of the Township of Franklin, County of Somerset and State of New Jersey, Franklin Township Code Chapter 226, Traffic and Vehicles is hereby amended with the addition of the following:

SECTION I

Section 226-20. STOP INTERSECTIONS.

Pursuant to the provisions of N.J.S.A. 39:4-140, the intersections described are hereby designated as Stop Intersections. STOP signs shall be installed as provided therein.

SECTION II

The Code of the Township of Franklin, Chapter 226, Vehicles and Traffic, Section 226-31C – Regulations for the Movement and Parking of Traffic on All Other Private Property is amended as follows:

C. Regulations for the Movement and the Parking of Traffic on All Other Private Property

In accordance with the provisions of N.J.S.A. 39:5A-1, the regulations of Subtitle 1 of Title 39 are hereby made applicable to the properties listed.

SECTION III

Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the Ordinance shall not be affected.

SECTION IV

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

SECTION V

This ordinance shall take effect immediately upon adoption and publication according to law.
