

**ORDINANCE NO. 3884-10**

**AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET AND STATE OF NEW JERSEY, MORE PARTICULARLY CHAPTER 226 - VEHICLES AND TRAFFIC, SECTION 226-20 – STOP INTERSECTIONS (EAST MILLSTONE AREA AND HALL STREET AREA)**

**SUMMARY**

An ordinance amending the Traffic Ordinance to add the following stop intersections in the East Millstone Area: Market Street & Livingston Avenue; Market Street & Bradley Avenue; William Street & Bradley Avenue; Elm Street & William Street; Elm Street & Franklin Street; Wortman Street & Elm Street; Wortman Street & Livingston Avenue; and Franklin Street & Welsh's Lane. It also adds the following stop intersections in the Hall Street Area: Madison Avenue & Hall Street and Adams Street & Madison Avenue.

**BE IT ORDAINED** by the Township Council of the Township of Franklin, County of Somerset and State of New Jersey, Franklin Township Code Chapter 226, Traffic and Vehicles is hereby amended with the addition of the following:

**SECTION I**

**Section 226-20. STOP INTERSECTIONS.**

Pursuant to the provisions of N.J.S.A. 39:4-140, the intersections described are hereby designated as Stop Intersections. STOP signs shall be installed as provided therein.

Market Street and Livingston Avenue  
Market Street and Bradley Avenue  
William Street and Bradley Avenue  
Elm Street and William Street  
Elm Street and Franklin Street  
Wortman Street and Elm Street  
Wortman Street and Livingston Avenue  
Franklin Street and Welsh's Lane  
Madison Avenue and Hall Street  
Adams Street and Madison Avenue.

**Stop Sign On:**

Livingston Avenue  
Bradley Avenue  
Bradley Avenue  
William Street  
Franklin Street  
Elm Street  
Livingston Avenue  
Welsh's Lane  
Hall Street  
Madison Avenue

**SECTION II**

Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the Ordinance shall not be affected.

**SECTION III**

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

**SECTION IV**

This ordinance shall take effect immediately upon adoption and publication according to law.
