

**ORDINANCE NO. 3900-10**

**AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET AND STATE OF NEW JERSEY, MORE SECTION 226-31 (C) - REGULATIONS FOR THE MOVEMENT AND THE PARKING OF TRAFFIC ON ALL OTHER PRIVATE PROPERTY - ADDING QUAIL CREST I.**

**SUMMARY**

An ordinance amending the Traffic Ordinance to provide regulations for the movement and the parking of traffic in Quail Crest I including regulations for parking; stopping/standing prohibited; stop intersections; tow away and no passing zones.

**BE IT ORDAINED** by the Township Council of the Township of Franklin, County of Somerset and State of New Jersey, Franklin Township Code Chapter 226, Traffic and Vehicles is hereby amended with the addition of the following:

**SECTION I**

The Code of the Township of Franklin, Chapter 226, Vehicles and Traffic, Section 226-31C - Regulations for the Movement and Parking of Traffic on All Other Private Property is amended by including the following addition:

**C. Regulations for the Movement and the Parking of Traffic on All Other Private Property**

In accordance with the provisions of NJSA 39:5A-1, the regulations of Subtitle 1 of Title 39 are hereby made applicable to the properties listed.

Regulatory and Warning signs shall be erected and maintained to effect the above designated speed limits authorized by the Department of Transportation.

**Quail Crest I**  
Tow Away Zones

Any vehicle parked or standing as to obstruct or impede a normal flow of traffic, block entrances or exit ways, loading zones, oil fills, any grass area, pedestrian walkway, refuse containers or present in any way a safety or traffic hazard may be removed by towing the vehicle at the owner's or operator's expense.

Signs, pavement markings, installation and maintenance. All signs, posts, bolts or other necessary materials shall be installed and paid for by the applicant. Work shall be checked by the Police Department to insure installations meet state and federal specifications, and all signing shall conform to the current Manual on Uniform Traffic Control Devices.

Violations and penalties. Unless penalty is expressly provided by New Jersey statute, every person convicted of a violation of this section or any supplement thereto shall be liable to a penalty of not more than \$50 or imprisonment for a term not exceeding 15 days or both.

**SECTION III**

Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the Ordinance shall not be affected.

**SECTION IV**

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

**SECTION V**

This ordinance shall take effect immediately upon adoption and publication according to law.
