

ORDINANCE NO. 3902-10

AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET AND STATE OF NEW JERSEY, MORE PARTICULARLY CHAPTER 226 - VEHICLES AND TRAFFIC, SECTION 226-13 - PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS AND SECTION 226-20 - STOP INTERSECTIONS (PARK HILL ESTATES)

SUMMARY

An ordinance amending the Traffic Ordinance prohibiting parking on Canoe Lane; Ten Mile Run Blvd.; Timberhill Drive; Cobblers Circle; Mine Brook Lane; and Yardley Court and adding stop intersections at Timberhill Drive and Ten Mile Run Blvd (stop sign on Ten Mile Run Blvd.); Timberhill Drive and Timberhill Drive (stop sign on Timberhill Drive); Timberhill Drive and Yardley Court (stop sign on Yardley Court); Timberhill Drive and Canoe Lane (stop sign on Canoe Lane); Timberhill Drive and Canoe Lane (stop sign on Canoe Lane); Timberhill Drive and Cobblers Circle (stop sign on Cobblers Circle); Timberhill Drive and Cobblers Circle (stop sign on Cobblers Circle); Timberhill Drive and Mine Brook Lane (stop sign on Mine Brook Lane); Cobblers Circle and Mine Brook Lane (stop sign on Mine Brook Lane).

BE IT ORDAINED by the Township Council of the Township of Franklin, County of Somerset and State of New Jersey, Franklin Township Code Chapter 226, Traffic and Vehicles is hereby amended with the addition of the following:

SECTION I

Section 226-13, Parking prohibited at all times on certain streets is amended to **add** the following:

No person shall park a vehicle at any time upon any of the streets or parts thereof described.

Timberhill Drive	Odd House #s	Entire Length
Cobblers Circle	Even House #s	Entire Length
Mine Brook Lane	West	Entire Length
Yardley Court	North	Entire Length

SECTION II

Section 226-20, Stop intersections is amended to **add** the following:

Pursuant to the provisions of N.J.S.A. 39:4-140, the intersections described are hereby designated as Stop Intersections. STOP signs shall be installed as provided therein.

Timberhill Drive and Timberhill Drive	Timberhill Drive
Timberhill Drive and Yardley Court	Yardley Court
Timberhill Drive and Canoe Lane	Canoe Lane
Timberhill Drive and Canoe Lane	Canoe Lane
Timberhill Drive and Cobblers Circle	Cobblers Circle
Timberhill Drive and Cobblers Circle	Cobblers Circle
Timberhill Drive and Mine Brook Lane	Mine Brook Lane
Cobblers Circle and Mine Brook Lane	Mine Brook Lane

SECTION III

Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the Ordinance shall not be affected.

SECTION IV

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

SECTION V

This ordinance shall take effect immediately upon adoption and publication according to law.
