

**RESOLUTION - AWARD BID – CENTRAL STATION MONITORING FOR MUNICIPAL BUILDINGS AND REPAIR SERVICES AS NEEDED

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified in writing hereon that funds are available and the Municipal Attorney has reviewed the certification of the Chief Financial Officer and is satisfied that said certification is in proper form; and

BE IT FURTHER RESOLVED, that continuation of the terms of this contract beyond June 30, 2009 is contingent upon availability of funds in the 2010 FY Budget, and in the event of unavailability of such funds, the Township of Franklin reserves the right to cancel this contract.
