

RESOLUTION – EXTEND CONTRACT TO MIDCO WASTE SYSTEMS FOR COMPACTOR RENTAL AND RECYCLING CONTAINERS (CONTAINERS THROUGHOUT THE TOWNSHIP AS NEEDED) & AWARD CONTRACT TO SAMR, INC., T/A SCER, SUPREME, INC. FOR CONTAINER FOR ELECTRONICS AND CONTAINER FOR LIGHT IRON AND FREON REMOVAL

WHEREAS, the Township Council awarded a contract for the recycling center on March 28, 2006 for a period of two years; and

WHEREAS, the bid specifications state the contract can be extended annually at the existing terms and conditions for up to an additional two years; and

WHEREAS, said contract was extended for one-year on March 11, 2008 as per Resolution #08-115; and

WHEREAS, the Department of Public Works recommended the extension of said contract for an additional one-year and Midco Waste Systems agreed for compactor rental and recycling containers (containers throughout the Township as needed); and

WHEREAS, the Department of Public works recommended to bid out for the container for electronics and a container for light iron and freon removal in hopes of securing better pricing; and

WHEREAS, only one bid was submitted from SAMR, Inc., t/a SCER, Supreme, Inc.; and

WHEREAS, the Chief Financial Officer has certified hereon that funds are available and the Municipal Attorney has reviewed the certification of the Chief Financial Officer and is satisfied that said certification is in proper form; and

WHEREAS, continuation of the terms of this contract beyond June 30, 2009 is contingent upon availability of funds in the 2010 FY Budget, and in the event of unavailability of such funds, the Township of Franklin reserves the right to cancel this contract;

BE IT RESOLVED by the Township Council of the Township of Franklin, Somerset County, New Jersey that the following contract be extended:
