

**AMENDED RESOLUTION - SPECIAL EVENT PERMITS – WEEK OF THE PEOPLE  
AUGUST 1, 2009 THROUGH AUGUST 8, 2009**

**WHEREAS**, a request has been received from the Somerset Community Action Program Inc. for permission to hold its annual Week of the People on the following days during the following hours and conducted at the following locations:

1. August 1, 2009
  - Kick Off Variety Showcase
  - 1:00pm - 8:00 pm
  - Franklin Middle School – George Ackerman Athletic Field
2. August 2, 2009
  - Basketball Tournament
  - 11:00 am – 7:00 pm
  - Naaman Williams Park
3. August 4, 2009
  - National Night Out & Getting to Know Franklin
  - 6:00 pm – 8:00 pm
  - Municipal Building Grounds
4. August 7, 2009
  - Musical Festival & Basketball Tournament Finals
  - 2:00 pm – 8:00 pm
  - Naaman Williams Park

**WHEREAS**, Somerset Community Action Program Inc. has requested that the Permit Fee of \$125.00 be waived since they represent a non-profit organization; and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Franklin, County of Somerset, New Jersey, that permission is hereby granted to Somerset Community Action Program Inc. to hold the Week of the People events as stated above subject to compliance with the requirements of Township Officials including but not limited to the Chief of Police; Director of Fire Prevention; Recreation Director and the Health Officer; and

**BE IT FURTHER RESOLVED** that the permit fee of \$125.00 be waived since said organization is a non-profit organization; and

**BE IT FURTHER RESOLVED** that the conduct of this special event requires a banner permit from the Township of Franklin and the County of Somerset for a banner to be displayed over DeMott Lane; and

**BE IT FURTHER RESOLVED** that the Applicant shall be responsible for providing off-duty police officers as follows as required by the Chief of Police:

- (1) August 1, 2009 - Variety Showcase – Five (5) Police Officers

August 2, 2009 - Basketball Tournament – Five (5) Police Officers

August 8, 2009 – Music Festival & Basketball Tournament – Five (5) Police Officers

- (2) Applicant shall deposit with the Township Finance Director, at least five (5) days prior to the event, an escrow amount sufficient to cover the cost of said off-duty police protection in accordance with the fee schedule set forth in Ordinance #1417;
- (3) Payment to said off-duty police officer for services provided shall be made by the Finance Department from said escrow deposit. Should escrow funds be found insufficient, the Applicant shall deposit additional funds with the Finance Department to cover the remaining cost of off-duty police protection;
- (4) Any unused monies deposited for off-duty police protection shall be returned by the Township Clerk to the person or organization making the deposit upon approval of the Chief of Police.

**BE IT FURTHER RESOLVED** that the Applicant shall be responsible for providing for a health inspector to check at various times during the event the noise level to ensure that it is in compliance with Municipal Code Chapter 167 to the satisfaction of the Health Director; and

- (1) Applicant shall deposit with the Township Finance Director, at least five (5) days prior to the event, an escrow amount sufficient to cover the cost of said health inspector in accordance with the fees set forth by the Health Director;
- (2) Payment to said health inspector for services provided shall be made by the Finance Department from said escrow deposit. Should escrow funds be found insufficient, the Applicant shall deposit additional funds with the Finance Department to cover the remaining cost of the health inspector;
- (3) Any unused monies deposited for the health inspector shall be returned by the Township Clerk to the person or organization making the deposit upon approval of the Health Director.
