

**RESOLUTION – REJECT BIDS FOR FIRE HYDRANTS (CATEGORY A) AND AWARD BID –
FIRE HYDRANTS REPLACEMENT PARTS (CATEGORIES B, C, D, E & F)**

WHEREAS, a notice to bidders for the receipt of bids for Fire Hydrant and Replacement Parts was published in the *Courier News* and posted on the Township’s website on June 11, 2009, addendum on June 26, 2009 for receipt on July 10, 2009;

BE IT RESOLVED by the Township Council of the Township of Franklin, Somerset County, New Jersey as follows:
