

ORDINANCE NO. 3717

AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET AND STATE OF NEW JERSEY, MORE PARTICULARLY CHAPTER 226 - VEHICLES AND TRAFFIC, SECTION 226-20 – STOP INTERSECTIONS (CEDAR BROOK DRIVE AND ROLLING ROAD AREA)

SUMMARY

An ordinance amending the Traffic Ordinance to add the following stop intersections in the Cedar Brook Drive and Rolling Road Area: Rolling Road & Cedar Brook Drive (Stop Sign on Rolling Road); Seelys Run & Cedar Brook Drive (Stop Sign on Seelys Run); Seelys Run & Rolling Road (Stop Sign on Seelys Run); Heather Drive & Rolling Road (Stop Sign on Heather Drive); Norris Road & Rolling Road (Stop Sign on Norris Road); Liberty Lane & Rolling Road (Stop Sign on Liberty Lane); Liberty Lane & Colony Court (Stop Sign on Liberty Lane); and Cedar Brook Drive & Heather Drive (Stop Sign on Cedar Brook Drive).

BE IT ORDAINED by the Township Council of the Township of Franklin, County of Somerset and State of New Jersey, Franklin Township Code Chapter 226, Traffic and Vehicles is hereby amended with the addition of the following:

SECTION I

Section 226-20. STOP INTERSECTIONS.

Pursuant to the provisions of N.J.S.A. 39:4-140, the intersections described are hereby designated as Stop Intersections. STOP signs shall be installed as provided therein.

Rolling Road and Cedar Brook Drive	Stop Signs on Rolling Road
Seelys Run & Cedar Brook Drive	Stop Sign on Seelys Run
Seelys Run and Rolling Road	Stop Sign on Seelys Run
Heather Drive and Rolling Road	Stop Signs on Heather Drive
Norris Road and Rolling Road	Stop Sign on Norris Road
Liberty Lane and Rolling Road	Stop Sign on Liberty Lane
Liberty Lane and Colony Court	Stop Sign on Liberty Lane
Cedar Brook Drive and Heather Drive	Stop Sign on Cedar Brook Drive

SECTION II

Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the Ordinance shall not be affected.

SECTION III

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

SECTION IV

This ordinance shall take effect immediately upon adoption and publication according to law.
