IMPORTANT RABIES NOTICE:

THE STATE OF NEW JERSEY MANDATES: A DOG LICENSE CANNOT BE OBTAINED UNLESS THE DURATION OF IMMUNITY FOR RABIES EXTENDS THROUGHOUT AT LEAST THE FIRST 10 MONTHS OF THE LICENSING PERIOD. YOU MUST UPDATE YOUR DOGS RABIES VACCINATION IF IT EXPIRES BEFORE 11/1/2019. FOR INFORMATION CALL 7328732500X6208.

IF ANIMAL IS DECEASED OR NO LONGER OWNED CHECK BOX AND RETURN THIS FORM

CONDITIONS:

1. Check Application for accuracy and make any necessary changes. Proof is required for spay/neuter and rabies status changes.
2. State Law requires that all Dogs be licensed and have a current tag affixed to a collar or harness.
3. Newly acquired dogs must be licensed within 10 days of acquisition or within 10 days of reaching the licensing age of 7 months. Registration fee is \$16.00 for a spay/neutered dog or \$19.00 if the dog is unaltered.
4. License must be issued in the name of an adult member of the household.
- 5 When validated, the Dog License will expire on 1/31/2020.
6. No dogs are permitted to run at large. Owners will be subject to a fine.
7. There is no charge for licensing of Seeing Eye, Hearing Ear or Service Dogs for the handicapped.
8. You must submit a rabies certificate good until [11/1/2019] to receive a 2019 license.
9. Any person applying for a dog license after January 31 is required to pay a late fee in addition to the applicable license fee. A court summons will be issued for non-registration.
10. FOR MAIL ONLY: Include postage in the amount of \$0.50 for each license or enclose a self-addressed stamped (\$0.50) envelope.

§ 115-9 Late licensing fee. A. Dogs

Fees for licenses issued after February 1 of each year shall include those license and registration tag fees set forth in § 115-A, In addition thereto, **a late fee shall be imposed as follows:**

<u>MONTHS</u>	<u>LATE FEES</u>
<u>February - April</u>	<u>\$5</u>
<u>May - July</u>	<u>\$10</u>
<u>August - October</u>	<u>\$15</u>
<u>November - December</u>	<u>\$20</u>

IMPORTANT - FREE CLINIC NOTICE

SPECIAL NOTICE TO DOG OWNERS

STATE LAW REQUIRES THAT A DOG'S RABIES VACCINATION MUST BE VALID FOR AT LEAST 10 MONTHS OF THE LICENSING PERIOD BEFORE A 2019 DOG LICENSE CAN BE ISSUED. THIS MEANS THAT IF YOUR DOG'S RABIES VACCINATION EXPIRES BEFORE NOVEMBER 1, 2019 YOU MUST HAVE YOUR DOG VACCINATED AGAIN BEFORE GETTING YOUR 2019 LICENSE.
